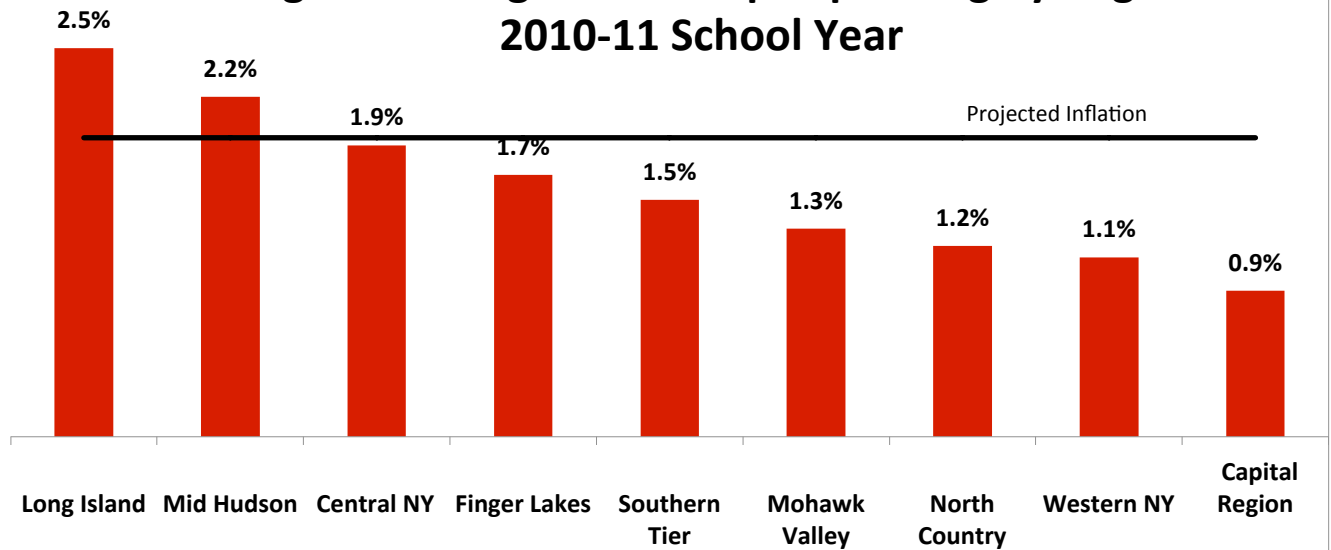


Budgeted Change in Per-Pupil Spending by Region 2010-11 School Year
